2020 Professional of the Year Award

Each MD|DC Credit Union Association affiliate may submit for nomination the name of one individual serving that credit union in a full-time paid capacity with managerial and/or supervisory responsibilities.

Each nominee should possess outstanding leadership qualities and should have made significant contributions to the growth and well-being of the credit union.

Nominations need not be limited to the recognition of achievement during calendar year 2019 yet must recognize achievement through December 31, 2019.

2020 Volunteer of the Year Award: The Janet C. Glomp Memorial

Each MD|DC Credit Union Association affiliate may submit for nomination the name of an individual serving that credit union on a voluntary basis.

The nominee's achievements, dedication, knowledge of credit union operations, and overall contributions to the credit union should be outstanding. The nominee should have made significant contributions to the growth of the credit union and/or credit union movement.

Janet C. Glomp began working for State Employees Credit Union of Maryland in 1969 where she served as a loan interviewer as well as organized and managed SECU's telephone services, accounts receivable, records and service departments. Janet also chaired the programs committee of the Maryland Association's Baltimore Chapter for six years and served two years on the Convention Committee.




